potential The cost of operation is still so little that I see no reason to bill the region for it. North Louisiana Area and Acadiana Area are both using the number as their area helplines now and is working out well. I encourage other areas to consider either using the Region helpline number or to port their existing numbers to the Region Yap install. It works really well and the cost is unbeatable. The Acadiana Area website has been rebuilt with a new provider and is much more functional now in addition to reducing cost. It is now set up to auto generate meeting printable lists as well as the online meeting lists on the site are pulled directly from the meeting database root server. That makes North, Central, Bayou, Lake, and Acadiana using these features. Davis also has this configured for Unity and NOANA but is waiting for approval from those areas before going live. I'd like to thank all the PR Chairs and/or designated meeting list coordinators of all the areas for their work and cooperation in keeping their meeting information current in the BMLT meeting database. Thank you Trevis, Daniel, Anthony, Allison, Jared, Pam, Stephen, Jessica, Matt, and anyone else I may have inadvertently left out - you guys rock! I am currently working with NAWS to deep clean their database and tie up loose ends. There are a few meetings they have listed that we don't. I have sent these back to areas to verify if they exist or not. We currently don't have a viable BMLT mobile search app so everyone uses the NAWS meeting search app so it's important we stay in synch. I'm assisting in a major PR effort in North Louisiana Area. They are getting tear off posters and business cards out from Shreveport to Monroe and all points in between. This is an ongoing effort that will be continuing throughout the year. I have also met or developed relationships with Drug Courts in Shreveport and Monroe as well as the DA's office in Columbia and Claiborne Parish as well as local courts in several cities. Several of these entities are giving NA business cards to people convicted of drug/dui in the courtroom or are being referred to us. The Claiborne Parish DA was especially welcoming and wanted several hundred cards - which I got to him quickly. He said most of the cases that cross his desk have something to do with drugs and he's sending them all to us and to get ready. We've also met with rehabs and other organizations. If I can help any of the areas with any of this please let me know and I will come see you. I have been slow to post some of the events on larna.org and let a few slip through the cracks. Greetings Members and Trusted Servants of the Louisiana Region:

Attached to my report will be minutes from the January LRCC Board meeting and minutes from a special board meeting held on January 31st to discuss the possibility of a virtual convention in 2021. I will forward minutes from our March meeting when I receive them.

Since our last RSC meeting, the LRCC has met 3 times. State mandated Covid restrictions were making it extremely difficult to find a hotel to host LRCNA38 in person. After much discussion, LRCC felt that time was running out to plan an in-person convention. We also strongly felt like our region needed some sort of recovery celebration. LRCC voted to host a one-day virtual convention. An adhoc committee was established, and BOD members Rock H. and Ron D. were appointed as LRCC liaisons/coordinators to work with a planning committee. I have attached the current flyer to my report and will make sure it is uploaded to www.lrcna.org as soon as possible. Please ask members of your areas to consider stepping up to help in any way they can to make this successful. Contact information is on the flyer. There is no charge to attend, and we will be accepting donations during the convention.

We are still seeking bids to host the 2022 convention. I have included the bidding guidelines in my report. The question was asked about hosting the convention in a hotel that is adjacent to a casino, so the Board would like to ask the region their thoughts on that.

The Board also discussed the banners from previous conventions. The only banners that were able to be digitized was in the collage done for LRCNA37. A motion was made and tabled to dispose of the banners. We wanted to advise the Region of that possibility and get any additional feedback.

 - h. Availability and cost of coffee
 - i. Placement of banners in main meeting space
 - j. Securable space for committee business and for merchandise sales

We have been saying for the past year that we are trying to publish a shorter, more easily translated NAWS News, and we are making good on that promise in this issue. TALI This is the first NAWS News since the passing of our World Board Chair, Tali M. She was a gift to us and to NA and we miss her more than we can describe here. We know many of you share the loss with us. She was grateful for the love of the Fellowship and the opportunity to serve and demonstrated that by facilitating a Conference participant webinar the day before she passed. We all honor her in that same spirit of service. facilitating a Conference participant

FINANCES

Our financial situation continues to -fluctuate. We are work-ing hard to weather the storm. We remain under budget for all expense categories except in-house production and legal. We have less control over income. By the end of last year, our literature sales began to improve, but net literature income was still almost 40% less than the same time the previous year. A signicant percentage of the literature being ordered has been coming from correctional and treatment facilities, many of which have been locked down with H&I panels not able to reach them. As the world is opening back up, literature sales are begin-ning to increase, but we remain committed to becoming more self-supporting through member contributions. Our long-term goal is to cover at least 70% of our expense for services from contributions not literature sales. Those ser-vices are roughly two-thirds of our budget; it's most of what we do, except for literature distribution and cost of goods. Under more normal circumstances (not a pandemic), World Services' expense for services are approximately \$5.5mil-lion, 70% of which is approximately \$3,885,000 per year. In the last fiscal year, contributions were just under one million dollars, which means we are a little more than a quarter of the way toward the goal.

Thank you so much to everyone who has made a contribution. Recurring monthly contributions are the most sustainable source of income for us, and we are happy to report that the total amount of member contributions had increased more than tenfold over the course of the last year. We have gone from fewer than 50 recurring contributors with a total of about \$2,000 per month, in February 2020, to over 750 members contributing a total of more than \$20,000 a month. Our only income area that improved in the last fiscal year was contributions. Thank you. Addicts can do anything when we put our minds to it. If 10,000 members contributed \$10 per month and another 10,000 contributed \$20 per month, we would almost reach our goal.
