With the Covid Pandemic subsiding I am incredibly grateful that we all made it. (Saddened for those we lost) And I love the silver lining that it produced! There are literally thousands of new members that came to us through virtual NA Meetings and have made a year clean without walking into the rooms (physically) of Narcotics Anonymous yet!

It was an honor and a privilege to serve at our Regional Virtual Convention. I was very saddened by the poor support and attendance of the members of our actual Region. Yet the message was carried and everything that I heard in terms of feed back was positive. Some gave more than eighteen hours in a row of Service. Thank you to all that served to make the Convention a success.

Thanks, Nikki, for sending out to the ASR's the "Vision and Purpose Statement" that was created by a collaboration of the U.S. Zones. And to clear up any confusion, the U.S. Zones is not a formal service body (yet). We are looking at ways to further carry the message to the still suffering addict and we recognize whom we serve. This collaboration comes from the Strategic Plan from the 2018 WSC [World Service Conference]. There are many that think that a formal U.S. Zones combined would greatly enhance our National PR/H&I and Outreach capabilities. For example, a U.S. Zones website that would connect all the Groups, Area's and Regions, Zones in the U.S. And in addiction to that give us a National presence with Government and the American Treatment Industry. This is all ideas at this time, nothing formal has been voted on by the Groups. And there seems to be many that have no understanding of what our Zones do... Simple example our Southern Zonal Forum are Nine Regions that come together for idea discussion, some service efforts like PR (internal and external), Outreach and Hospitals and Institutions. We as a body decided to hold off meeting in person until the Multi Zonal Service Symposium this August in San Antonio Texas. All Zones from the U.S. and around the World are invited to attend. At WSC Conference Participants meeting's that are happening virtually monthly we are looking at the practicality of holding the World Service Conference next April 2022 in Woodland Hills CA. in person. There is also a great deal of concern about the scheduled World Convention in Melbourne Australia. Contracts were signed and a decision will be made prudently very soon. One of the main concerns is the financial liability involved. The other concern is the Covid and it's restrictions.

Our World Services took an extremely hard financial hit at the beginning of and throughout the pandemic. We are still struggling, and it is crystal clear that dependance on Literature Sales is not a way forward. Moving the money through the service structure is critical. There is a "Contribute Button" at na.org! We are asking everyone to give what they can afford. You can make a contribution in someone else's name that you want to honor. You can make a onetime donation or make it recurring like a dollar for every year that you are clean monthly donation. You know the whole "Fully self-supporting declining outside contributions" piece. Please consider this personally and please announce at your Groups. Thanks!

I really hope that the workshop done Virtually with our friends from the NEZF (North East Zonal Forum) was good for our ASR's. (RCM's is what they're called across the US) This is another example of service's that our Zones provide to the Fellowship. Public Relations

PR has been busy. We actually had a PR subcommittee meeting in Alexandria on Sept 11. There were approximately 15 in attendance from North, Central, Acadiana, Bayou, and Lake areas. We discussed Billboards, Social media, & TV PSA's. Everyone participated and we got a lot of work done. We will be having another PR subcommittee meeting on Dec 4 in Baton Rouge and will be having them once a quarter. This is strictly a working meeting set up to be a day trip so more people can get involved. Cheap pizza at 11:00 am, meeting starts at noon and lasts two to three hours. I encourage everyone who is interested in PR to attend as we need all your input. I would like to elect a PR subcommittee vice chair and a secretary at the next meeting so if you are interested and committed please come to the meeting on Dec 4.

The poster size billboards (10.5' x 22' 8") from Lamar Advertising were overwhelmingly supported. The minimum package is \$5000.00 for fifty billboards. We are paying their cost for the billboard cover. They will use this for cover when they have unused space. I put in a motion for that at July RSC. This can be added to and any area can add more billboards at \$100.00 ea if they want more in their area.

We also discussed social media. I ran a test post over a year ago targeting the state of Louisiana. I spent \$20.00 for an 8 day boost using a NAWS approved PSA video downloaded from na.org. This reached 6,474 people with 1,249 play Thruplays. That comes to approximately \$0.02 per Thruplay. The more you spend the more times they run the PSA. I'd like to spend \$80.00 to \$100.00 per month. I contacted an old friend that used to work for me in R&D in a company I had years ago that is now the chief engineer at three of the high power TV stations in Shreveport. It turns out that his wife handles PSA's for those stations. I will be getting all the specs next week for format, length, acceptable content, etc from her next week. It is my hope we can get set up with these stations and use it as a blueprint to get in the other markets around the state. I have contacted Jared L in New Orleans about the cost of producing a PSA but currently he is tied up on a shoot so that's not nailed down yet. I should know something soon.

All content for billboards, social media, TV PSAs, etc will be determined by the PR subcommittee or a subset thereof. Any NA member can show up and be part of the PR subcommittee. You are a member

when you say you are – and physically show up.

I'm asking for a 10,000.00 PR budget which will fund our Region helpline and larna.og, as well as the the items discussed above.

Greetings Members and Trusted Servants of the Louisiana Region:

I have asked our Vice Chairperson, Bob Storer to present my report today as I have an unexpected family situation to attend to. Since our last RSC meeting, the BOD has met once. We are still seeking bids to host the 2022 convention. We have 2 areas that have expressed interest in hosting the convention in May 2022, however, we have not received any valid bids as of today.

We are working diligently to update our status with the IRS. When our current treasurer tried to file taxes a few years ago, the IRS said we were out of compliance because previous board members had not submitted information or filed taxes. All relevant financial documents were destroyed in the 2016 flood near Baton Rouge, and the IRS has been informed of this. The pandemic has made it difficult to reach the IRS by phone, so we are working through a 3rd party to get the documents completed in order to rectify the situation. We are told it may take approximately 90 days for the IRS to process our application.

To regions and zones:

As you have heard, Conference participants came to a consensus to postpone the next World Service Conference until 2023 in the hopes that we will be able to meet in person at that time. The WSC will convene for a partial, interim, virtual meeting in 2022 to make decisions that are required by law and policy, as well as to decide on the Spiritual Principle a Day book, but the conference cycle this time will be three years, ending when the 2023 meeting closes.

You can read the text of the recent motions passed by participants on www.na.org/conference. That page also contains two recommendation reports from the World Board that contain more details about plans for the conference. We are writing to you now about one aspect of these decisions: term limits. As we have reported, we will be asking participants to extend the terms of the world-level trusted servants that are due to expire in 2022 for one year. Six world-level trusted servants have terms that would expire in 2022: three board members, two members of the HRP, and one WSC Cofacilitator. It makes sense to us that they would stay in their positions for the length of the three-year cycle, to help maintain continuity and familiarity with the work of the cycle.

Experience has shown that continuity of trusted servants in a conference cycle helps to make the WSC more effective so we are encouraging regions and zones to consider making similar decisions related to the terms of their delegates and alternates. Of course, each region and zone is free to make its own decisions about trusted servant terms, but we are writing to explain the situation and to let you know what we will be recommending for World Services' trusted servants in case a similar decision makes sense for your service body.

The future of the WSC, after 2023, is something that participants will have to collectively decide. If no decision is made to the contrary, the next World Service Conference would take place in 2025, resuming the two-year cycle.

Virtual Meetings

We have posted a draft of a new piece of service material, Virtual Meetings Best Practices: www.na.org/toolbox. NA members around the world have helped to create this piece by sharing locally developed resources and by participating in the web meetings we have been hosting for the last two years. The new draft tool covers a range of topics, including keeping meetings secure from disruption, welcoming newcomers, and practicing the Seventh Tradition.

We encourage you to review the draft posted on the Toolbox project page www.na.org/toolbox, where you will also find a short survey to gather input until 30 November. You are welcome to complete the survey as an individual member or with others in a group or service event setting.

Thank you to everyone who has helped with the project so far. We look forward to publishing this new, much-needed, piece of service material soon.

WSC Plans

Conference participants have decided to adopt the World Board's recommendation that the World Service Conference be pushed to 2023, in the hopes that we will be able to gather safely in person then. In the meantime, there will be an interim, virtual WSC meeting in 2022 to make the decisions necessitated by law or policy as well as decide on the Spiritual Principle a Day book...

We intend to publish an interim combined *CAR/CAT* (*Conference Agenda Report/*Conference Approval Track) document by the upcoming *CAR* publication date, which is 24 November in English, 24 December for the translated versions. We also will post an updated version of *A Guide to World Services in NA* soon that includes the new deadlines and recent related decisions by Conference participants.

The two recommendation reports from the board posted on www.na.org/conference contain more information.

Little White Book Input Deadline

Don't forget: the deadline to give input on the 60th anniversary Little White Book (LWB) being proposed is coming up. As a reminder, we would like to publish a version of the LWB that includes the stories from all of the different language versions.

A Guide to World Services in NA explains that, "If a local NA community with a history of successful translation efforts wishes to develop local stories, they may do so for the Little White Book." In line with this policy, 13 language versions of the LWB include local stories. We would like to combine English translations of all of these stories, together with the eight stories in the English LWB, under one cover. The Fellowship Intellectual Property Trust allows the World Board to bundle and repackage already published NA literature providing 120-day notice is given to the Fellowship. We posted that notice in June, and the deadline for input is 31 October. For more information see the June 2021 Notice for LWB posted at www.na.org/fipt.




