- A motion was made by Sabrina A seconded by Ashley D. to request a \$500 donation from the area to help fund the “out of the dark, into the light” group function June 24th. Please see attachment for more info. The motion went back to groups for voting and the motion failed.
- A motion was made by Sabrina A seconded by Emily requesting a \$200 donation from the area to help fund the “out of the dark, into the light” group function June 24th. Please see attachment for more info. The motion was voted on by the GSRs and the motion failed. However, many of the groups brought money to donate to the function.
- A motion was made by Robbie G seconded by Randall that voting for ASC positions be done by a straw poll. The intent would be for GSRs to vote impartially and not worry about if other members knew their vote. The motion was voted on and failed.
- A motion was made by Amy G seconded by Doug to mail a \$200 check to region. This was voted on by GSRs and failed.
- A motion came back from regional that the ASR and Alternate ASR can only vote as an area at regional. This was voted on by the GSRs and the motion passed.
- It was noted by Robbie G. and agreed upon by other members that the Unity Area budget should be revisited in the next June meeting. Section XXIX of the guidelines outlines the current encumbered funds and budgets for the subcommittees.

The guidelines have a clean time requirement of 5 years for the Treasurer position. This clean time requirement was waived in the past so that Chad could serve as the Vice Treasurer and learn the job so he could eventually take over. This should be considered by groups for voting/elections.

Vice Treasurer: Scott was nominated for Vice Treasurer by Sean and seconded by Emily. Scott has 3 1/2 years clean time. The guidelines have a clean time requirement of 5 years for Vice treasurer. This clean time requirement was waived in the past so someone with less than 5 years clean time could serve

as the Vice Treasurer. This should be considered by groups for voting/elections.


