MAILBOX REPORT- The mailbox was not checked.

OLD BUSINESS:

- The PA system was purchased for \$150, and Michelle asked to be reimbursed for this purchase.
- Michelle made a motion seconded by Bobby C. to purchase three foot lockers for \$170 to preserve the items for the A&F committee. Pros were discussed that would protect the goods. There were no cons. 6 voted for, 0 against, 0 abstentions. The motion was passed

NEW BUSINESS:

- Robbie made a motion to donate 5 Basic texts to the Pre-Christmas night of fun. The motion was voted on and 6 voted for, 0 against and 0 abstentions. The motion was passed.
- Bobby made a motion seconded by Henry to restore the RSC name back to Louisiana Region of Narcotics Anonymous with the IRS and Secretary of State. This is to accurately reflect the name we have been using and the recent name change was not voted on in area. The motion was voted on and 5 voted for, 1 against, and 0 abstentions. The motion was passed. Robbie will take the motion form with him to the next regional committee meeting.
- Bobby made a motion seconded by Henry for the RSC to post their minutes on the Louisiana Region of Narcotics Anonymous website within 30 days of the latest session. The regional minutes have not been posted on the website since Jan 2023. The motion was voted on and 6 were for the motion, 0 against and 0 abstentions. The motion passed. Robbie will take the motion form with him to the next regional committee meeting.
- Bobby made a motion seconded by LaTaisha to restore the RSC to being a service body by dissolving/terminating its non-profit status. The intent is application of traditions 8 & 9 to protect the members from possible litigation and liability. This change never came to the Unity area to vote on. Pros were discussed with restoring former status, because a nonprofit status

could open the region up for possible litigation or liability. A con discussed was that the non-profit status protects the region from paying taxes on their money. The motion was voted on and 5 were for the motion, 0 against, and 3 abstentions. The motion passed. Robbie will take the motion form with him to the next regional committee meeting.

- A motion was made by Henry seconded by Chari to look into the mailbox situation to see if we still need a mailbox or if anything needs to be done with the mailbox. Amy G. had a point of information that in the past the Unity area had decided to get rid of the mailbox. However, the cost of the mailbox had been paid that year, so we were going to let it run its course. This motion was tabled until the next meeting, so Ashley B. can look at the past minutes to see when this was last discussed.
- Chari updated the area on how the fundraiser went for the Stairway to Life meeting. She said that no one attended from the Unity area and that she had expected more support at the fundraiser as well as on social media and announcements at the different meetings. Other members mentioned that the fundraiser had been promoted on the NA unity Facebook page as well as announcements made in groups. Throughout the discussion it was noted that no one had responded to Chari's message inquiry to the NA Unity area page. It was also recommended that Chari attend other fundraisers in rural areas to see if she can get some ideas that will attract more attendance in the future.
- A motion was made by Henry seconded by Emily to add the current Unity area Vice Chair, Chair, and PI chair as admins on the Unity Area NA page on Facebook as well as the Unity area website. This is to ensure accountability. This was voted on and 8 were for the motion, 0 were against, and there were 0 abstentions. The motion was passed.
- A motion was made by Robbie seconded by Bobby to set aside \$1000 in the Unity area prudent reserve for possible Public Relations posters. This was voted on and 4 voted for the motion, 0 voted against, and there were 3 abstentions. The motion was passed.
- Chad asked for information on how to pay the rent for area meeting space. Michelle said that he needed to reach out to Mr. Melvin to coordinate dropping the check off.
- Robbie made a motion to not discuss regional guidelines until there is an official motion from the region. The directive to vote on the new guidelines was sent to Robbie via email and was not an official motion. This was voted on and 5 for the motion, 0 against, and there was 1 abstention. The motion was passed.




