5. Regional Delegate Report – Bob St. – Report Submitted

Regional Delegates Report for October 2025 RSC meeting

Hello all,

There was a Conference Participants meeting on August 16th but rather than getting updates and info from the World Board, it was focused on continuing development of the Strategic Plan for NA.

We were broken into small groups virtually, and in my group, we first looked at objective 3: "Improve the ability of virtual groups and service bodies to fully participate in the service system and for their voices to be heard as part of the NA fellowship's conscience." The "solution" they came up with was, "Collect best practices for virtual groups and areas to participate in NA Services." They also asked, "How are in person meetings being inclusive of those attending virtually?"

Objective 4: "Further the concept of coordination and collaboration within the service system and the understanding and appreciation of complementary roles and contributions to A Vision for NA service.

Solution: Create a contemporary guide to service in NA to replace a Guide to Local Service. Consider a modular-based approach similar in format to the Basics series. Include guidance on how to incorporate virtual groups in the service system. As resources are created, consider possible future alternative format versions of content (e.g., videos).

Objective 5: Through mentorship training and tools, increase continuity of service and inspire members of all ages and stages of recovery to be of service

Solution: Create messaging and tools to help existing trusted servants create an environment that inspires members to be of service, and establish a pipeline of developing trusted servants on an ongoing basis; Create mentoring guidelines and resources to encourage younger members (in age and recovery) to be of service.

Objective 6: Create tools for groups and service bodies to offer convenient ways for members to contribute, and to facilitate and encourage the distribution of funds through all components of the service system.

Note: I commented that direct contributions are changing/have changed the structure of NA in that service bodies are no longer wholly dependent on the bodies they work for, for funding.

Asked what we think is most important: I said eliminate redundancy, and increase cooperation/collaboration among service bodies.

Part 2: World Service Structure and Operations

Objective 10: Further refine and describe the 3-year conference cycle, including major meetings, policies, planning process, deadlines, and guidelines.

Solutions- Use the experience gained over the two-cycle experiment to draft descriptions and guidelines for a 3 year cycle and include in GWSNA... Evaluate and refine the collaborative planning process for ongoing implementation.

Objective 11: Create a financially sustainable model for the World Convention (CWNA), in harmony with our eleventh concept, that meets the needs and expectation of the fellowship in a changing world. Solutions: Consider holding WCNA every 5 years with flexible rotation of locations, and cap attendance. Explore how to monetize virtual attendance

• I said not the right solutions... Need to make not losing money the priority. BC RD said we don't need the glitz and glamour... strip it down... Georgia RD: stop planning to lose money in some locations... RD Carolina: I think capping attendance would be worth trying... Hard to plan for unknown # of people... RD Free State: Have it in smaller markets, larger venues, limit attendance, but make it a true world convention... Hold it out of US more years than not... RD South Dakota: In line with 5 year rotation and monetizing virtual attendance... There was a lot of concern about the loss of money... Get rid of the glitz... not really needed... Go into countries that would be cheaper and don't get the attention... RD Arizona: Stay with 3 years, reduce glitz and glamour... Better planning for numbers... Better organization... BC RD: Canadian convention essentially caps attendance in that when facility is full, they look for overflow. ... RD Georgia: Sad that Germany has never had WCNA...

Objective 12: Raise understanding of the need for and importance of adequate financial resources in carrying the NA message of recovery.

Solutions: Send quarterly 'thank you' messaging with links to social media content. Encourage showing of fellowship development videos at events and conventions throughout the service system.

I wrote: To raise understanding of need and importance of financial support of NAWS, NAWS needs to do PR on what it is spending on specific things and highlighting the impact of those interventions.

Objective 13: Continue to evaluate and adjust activities at NA World Services to best support its roles and functions in a changing world.

Solutions: Continue to charge the Business Planning Group with helping the WB respond flexibly and responsibly to the realities of a changing world in operating the business of NAWS.

Continue use of focus groups as a flexible means to be more inclusive and accountable in seeking member input and engagement.

Use zones as focus groups?

Have Regions report to Zones, and zones report to WSC... Lets look at that again.

Since that CP meeting, there has been some additional commenting on the discussion board for CPs as well. Two main issues have come up and have generated a lot of interest. First, the price increase. Most folks seem to be saying, "We get it, you have to raise prices to keep up with inflation." But along with that has been a call for more information, or greater transparency if you like that phrasing, on how NAWS is actually spending money. The response from the WB has been essentially, we're doing a lot already! Specifically, people want to know about the distribution of "donations" from WSC. Where the free or discounted literature and such has been going.

There also have been some comments about the claim that \$750,000 of literature has been given away over the past year. Apparently that number is what NAWS would have gotten if they had sold the literature, but not what it was actually worth as in, what it cost them to produce. Many CPs seem to be saying, "If we have been misled on this, what else have we been misled on?"

Speaking of WSC, Scotty and I have registered and will be sharing a room to keep costs down (he has promised me he doesn't snore... I made no such promise!). I will ask for reimbursement of whatever a round trip airfare would be, but I think I'm riding my bike. I hate flying.

Scotty and I will be heading to Kentucky for SZF in a couple of weeks. Given that the WSC is only 6 months away, I would hope that we will be having some discussions there about the issues that we are likely to be addressing at WSC. More will be revealed! I am asking for reimbursement of a 1-way airline ticket for this (\$220.19), and for the hotel room (282.38).

We need to hear from ASRs what you want in regards to CAR workshops. Traditionally, the RD and RD-Alt have traveled all over the region to lead workshops in individual areas. You'll remember that with the Interim WSC though, we didn't have time to do that, and instead we did a zoom workshop that was recorded, and able to be viewed live, or whenever was convenient for individual areas. Another advantage of that was that everyone started out with the same information. Personally, I like the idea of Scotty and I doing a Zoom workshop as soon as we can after the CAR comes out (November 3rd).

Finally, I want to update you on the RSC's submission of Bob Singer's name for nomination to the World Board. The process is supposed to be that after a name is submitted, the Human Relations Panel creates an electronic file on that person, then contacts them and asks them to fill out various forms and answer questions for that file. Then they interview folks, add that info to the file, and then use the file to decide who will actually be nominated. Elections are held at the WSC.

Bob Singer contacted me some months ago to say that he had not been contacted by the HRP. At the next CP meeting, in early July I think, I asked about this and later that week I was told that they sent him an email but never heard back. I facilitated contact between Bob and the HRP and they gave him a username and password to get into the electronic file and answer questions. It didn't work. The system didn't recognize him and he couldn't get in. This went on right up until about a week ago when he was finally able to get into the system. So, hopefully, that process will go much more smoothly from this point forward and I will let you know what happens, when I know what happens.
