There was discussion about the PI report:

- Questions about signs being hung in St. Charles Parish. The chair will follow up again to see if anyone is available from the centers there to assist.
- Discussion about Area and Subcommittee guidelines available / updated editions; the H&I guidelines need to be updated on the website, and the committee is hoping to have those available by next Area meeting.
- Discussion regarding a policy on time expectations for the Area minutes to become available before the next meeting. There is currently no policy, although there is a policy for the Regional Minutes which was originally introduced by this area - 30 days following the meeting (1/3 of the time between each quarterly meeting.)

Motion was introduced to set a time limit on how long the minutes should be prepared in advance of the next meeting. Concern is regarding having the minutes to allow the homegroups access to the minutes before the business meetings are held. Original motion suggested 1 week prior to the following meeting;

Good afternoon all,

LRSCNA Last met October 4-5, 2025, the next LRSCNA meeting will be held January 10-11, 2026 in Acadiana Area, which was mentioned during the previous Unity Area monthly meeting.

There has been minimal activity in regards to changes/updates since last month's area. I have included last month's report at the bottom of this month's report for reference, but don't intend to go back over it unless requested to do so.

Updates from last month's report are as follows:

The ASRs received the minutes from region Oct 24, and they were uploaded to the Unity Area website (Thanks, Michelle!). A corrected version of the minutes was sent out November 3, and I believe those were also added to the website, but due to some personal technical issues, I was unable to verify yet.

I added two flyers from our regional delegate to the Unity Area Facebook page – one is in regards to discounts for the Lonestar Literature, as they will be closing. The other is for the Southern Zonal Forum hosts the "CAR" (Conference Agenda Report) virtual workshop which will take place November 22, 2025 from 9:00am – 11:00am CST; Meeting ID: 899 0775 9952; Passcode: 121212

No motions were made that needed to be brought back to areas/groups at the last region. All motions that were made and voted on are in the region minutes, including H&I Learning day reimbursement, and secretary supply reimbursement. We also voted to request SZF to take the lead to develop PSAs for social media. All motions brought to this region passed.

As a reminder, World just announced a 15% increase in Literature prices beginning in 2026. I believe this may have been discussed last area, but as a reminder or in case it was not, Unity may want to consider making an additional order prior to the close of the calendar year.

ASR Report 10/19/2025

LRSCNA Last meeting October 4-5, hosted by NorthShore Area, who very graciously received us and put on a very nice function that brought money back to the region.

I have yet to receive the minutes from the region, which the newly elected secretary said she would try to get done by today. I inquired about them, and have been told that a couple of pieces of information from other members are needed before they are complete, but should be done soon

More information will be better relayed once they are received, and they will be given to the PR chair to add to the Unity Area website.

Here are some of the highlights as according to my notes:

All Areas were in attendance other than Greater Baton Rouge

- Regional Service Delegate Bob S posed the question what does each area need from world?
 - It was brought up by almost every Area that meeting attendance is down
 - Several areas mentioned that their potential new members seem to gravitate towards AA instead
 - Most areas have noted that they have seen a decline since Covid and that many members, both seasoned and new seem to be favoring Zoom meetings
 - New Orleans mentioned an issue with predatory behavior which has recently come into the spotlight. They are open to suggestions on how to address, as much of the issue seems to be with the treatment centers, and it is acknowledged that many in that situation don't know how to act in according with not only meeting etiquette but general social acceptability
 - Discussion was held around topic. Was also brought up that this is not a problem exclusive to newcomers or to one specific gender or other, and that it needs to be addressed and people held accountable for their actions
 - Suggestions made to quit co-signing and to speak up; Potentially holding meeting topics on predatory behavior and meeting etiquette; Possibly incorporate meeting conduct within the readings
 - Areas also expressed a lack of willingness of members to participate in service work.
 - Brought up suggestions for new literature:
 - "Benefits and Importance of Service Work"
 - "Stick and Stay"
 - "Benefits of Human Contact and Sharing the Experience" (to encourage in-person meetings and not exclusively Zoom)
 - Of these

- Service work is being actively being addressed and will be able to be read about/shared about in Bob's report in the pending minutes
 - Stick and Stay held no further discussion
 - Literature on the Benefits of human contact within in-person meetings was well received by region's members and is anticipated to be brought up the chain by our delegate
- The Regional Gumbo Cook-off spent \$387 and took in \$1000, for a profit of \$703 which will be spend on Literature for Louisiana Prisons
- Pre-Christmas Night of Fun continues to need support from the service perspective. Many members of the Unity Area are currently selling tickets, myself included
- Upcoming Events include
 - Moonlight Madness campout
 - Acadiana Area (Lafayette) holding Halloween function and costume contest from 11am-4pm on October 25
 - New Orleans Halloween Function on October 31
- Lonestar Regional Office is Closing – Will no longer be able to get literature from there after the end of the year.
- Additionally, Literature prices are going up at the end of the year from World
- The CAR comes out on November 3. There will be a workshop in Philadelphia, with some discussion of virtual/pre-recorded workshops so that Areas can all get the same information and get a better idea of what the CAR includes
- It was mentioned from our Regional Delegate that there is pressure at the World level to be more inclusive of Zoom meetings**
- Motion for Angola was out of order – Region already has a standing H&I commitment for Angola that was active but not included in the policy
- Other two motions regarding what is sent to World and Southern Zonal Forum both failed. It was discussed that the guidelines had seemingly been misinterpreted, and LARCNA will ensure that it can cover its own bills prior to sending donations
- The Budget is currently being worked for 2026
- Regional Policy changes will begin coming out in a page quarterly when Region meets
- Information needed for getting the minutes uploaded to the LARNA.org website was given to secretary. Previous meeting minutes appear to have been added as of the time that this report was written.
- Next LARSCNA meeting is to be held January 10-11, 2026 in Acadiana Area, which is Lafayette. I do intend to request Area to cover lodging for that meeting.

An additional note that I have discovered recently- I was not able to find a link to LARNA.org website from the unityna.org website. Wanted to make note as I would like to address with the Unity's PR to see if it can be added

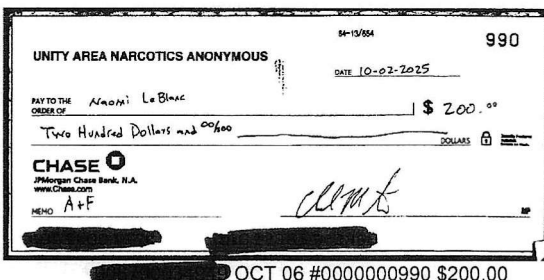
