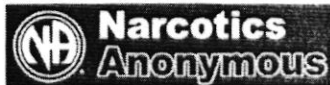

**Activity/Event Report:**

Halloween Bash was a successful and fun event! We had tons of compliments on the food spread, the decorations, and the entertainment. We had about 20 participants in the costume contest overall, and we had approximately 48 paying attendees.

The breakdown for the incoming funds are as follows:

Seed Money - we received \$800 in seed funds from the area.

Donations - we took in \$325 in homegroup donations.

Door Fee - we took in \$719 in entry fees.

Tarot - we took in \$95 from the tarot readings.

50/50 raffle - we took in \$107 from the raffle.

Cashapp - we took in \$80 at the door for both 50/50 and entry fees.

Returned items - we returned \$19 of items from the food/drink budget to Sams.

**Total income: \$2,145.64**

The breakdown of the outgoing costs for the event are as follows:

Food/drinks/serving supplies - \$634.55

Decorations/Costume Contest - \$91.53

Venue - \$200

**Total costs: \$926.08**

**Returned Profit to Area: \$1,219.56**

**Upcoming Event:** Thanksgiving meeting to be held tentatively set at St. Matthews like last year. We will be requesting \$50 for refreshments for the meeting and plan to hold it at the usual time beginning between 7 and 8 pm.

**Motion to be introduced:** We are introducing a motion during new business for a storage unit to be added to the Unity Area annual budget. The reason for this motion is the amount of decorations and equipment the area now has ownership of, and to relieve the burden on committee members of carrying/holding these items from year to year. It should also increase the safety of the items, so that a trusted servant always has access to the storage unit in the event of any potential committee member's relapse. We have attached the prices for ~~7~~ nearby storage units and we believe a unit close to Good Shepherd would be best, since this is where we conduct area business. This motion will need to go back to groups due to the annual costs.

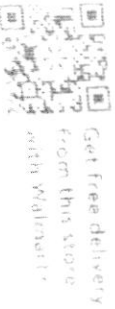

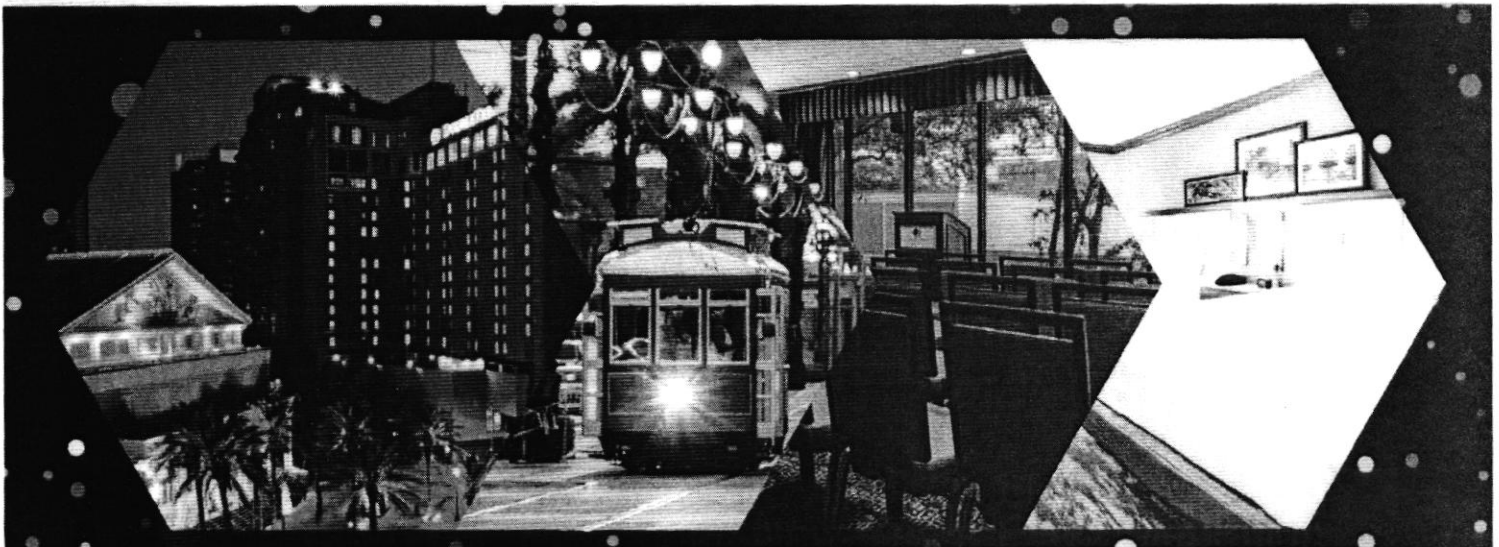
