ASR Report 1/18/2026

LRSCNA Last meeting January 10-11, hosted by Acadiana Area, who very graciously received us and put on a very nice function that brought money back to the region.

I have yet to receive the minutes from Region, which concluded only a week ago. I do not have an exact time frame yet, but will submit them to the PR Chair for the Unity website once they are received.

A more in-depth report should be available once the minutes are received, which I would anticipate being before the February UASC meeting.

Here are some of the highlights as according to my notes:

All Areas were in attendance other than Greater Baton Rouge Area and North Area

- Positions vacant and need to be filled:

- H&I
- A&F

- Points of interest:

- Former H&I Chair, Steven L, is currently still attending and willing to assist with a transition to a new chair. Additionally, without an H&I Chair, there is no current H&I Budget
 - Currently the newly elected vice chair, Daniel S, is doing some fill-in for these positions, and asks that all area events be brought to him so that they can be placed on the calendar promptly. This includes both Area functions and functions within the homegroups, so please get me any information you have on upcoming events for your homegroups ASAP.

- Fellowship Development reported:

- The PSAs will be brought up to the next SZF, as the last one was missed
 - FD Chair Richard T is reaching out to put the CAR Workshop on the website

- Regional Service Delegate, Bob S, gave additional information about the CAR and the workshop. He mentioned that the CAR basically seems to try to sell the motions, where the workshop is intended to give folks the bigger picture of the impact both for the positive and negative. Per a question regarding a brief explanation on what the CAR was (for visitors in the room), an explanation was started and somewhat ended up as a preview into the workshop held on Jan 17

- Five Motions were made for the CAR.
 - The First 3 were made by World:

- The First Motion is in regards to approving the revised IP 21: Staying Clean in Isolation, which is currently entitled IP 21: The Loner: Staying Clean in Isolation. The pamphlet was updated to not only change the title, but as a well-timed revamp of the pamphlet that now includes information on virtual meetings and other changes that are keeping with the current state of NA. The new pamphlet can be found in full in Addendum A at the back of the CAR
- The Second motion is the Adoption of the 2026-2029 Strategic Plan, which holds the goals and strategies to move towards the NA vision. It deals with attempting to address the struggles of NA (membership dips, inclusion, technology, etc). It is long. It is included in full in the back of the CAR in Addendum B. Please note that when your group votes whether to adopt the plan or not, you are voting for all of it or none of it – there is no partial adoption of the plan. The Conference Approval Track material contains the project plans that grow out of the NAWS Strategic Plan. That comes out in February, and it is my understanding that will also be something to look out for and while our RDs are not planning to collect official votes, they will absolutely accept input.
- The Third Motion is that the WCNA should be held ever 5 years, and be planned to be at minimum revenue neutral. The way the motion is worded, the it sounds that the decisions will be made to World Convention NA is not intended to be a fundraiser – while the convention doesn't always lose money, the plan is often for it to be allowed to. The thought is that NA receives enough PR and benefit to the local fellowship to justify losing funds. The last convention in Washington DC lost almost a million dollars, the one prior in Orland made over a million dollars. There has been discussion regarding a disapproval from some about the moving to 5 year as opposed to every 3 years. Like motion 2, it is either yes or no, there is no separating the financial portion vs the timing portion. Our regional delegates will bring up our concerns about if we agree with one thing but not another on this or other motions if we express them.
The details of this motion can be found in Addendum C.
- The Fourth Motion comes from AZ Region to create a project plan at WSC29 to research and explore opportunities and obstacles to provide the incarcerated, on tablets, with book-length pieces of literature in addition to the IPs and audio version of the 5th edition Basic Text that already exist on tablets. The World Board is opposed to this as they are already doing a lot for the prisons, and it is not as simple, nor as cost effective as people think, as it appears world is paying royalties on digital literature, apparently sometimes

causing the digital copies to be more expensive than the physical books.

As a point of interest, it was brought up in the workshop that some of the jails have gone completely paperless.

- The Fifth Motion comes from the FL Region to direct the World Board to implement AI interpretive solutions to replace the current live interpreters. Currently world is translated into multiple languages, and having in-person interpreters causes disruptions. The motion is currently written that it will eliminate the use of existing translators and start using AI. Florida understands that there would really need to be a transition period and is currently working on an amendment. It was brought up that AI is not perfect, but neither are the human translators.
- In Addition to the motions, there were two Discussion topics
- The discussion topics are meant to be brought back and discussed within the groups, and then we bring the input and points that are relevant to the members in our area to our Regional Delegate so that he can share them with World.
- The First Discussion Topic is regarding changing our literature such as the basic text and the readings to include gender neutral language, for example instead of saying “men and women,” using “people.” They are not discussing how God is referred to, nor are they looking to change the Steps and the Traditions at this time, as that is a lengthier process.
- The Second Discussion Topic is intended to address members being on Drug Replacement Therapy/Medically Assisted Treatment. They want to know how groups/areas are handling. Are groups asking if a person is on DRT when they pick up clean time? What about when they are up for a service position? Based on what they have heard from professionals at treatment facilities, the counselors are either hesitant to send patients to NA because of the harsh stance, or encourage them not to share that they are on it, which goes against the principle of rigorous honesty NA portrays as being vital to recovery.
- The CAR/World acknowledges that there has been a stagnation at best and a decline at worst regarding the membership of NA, and are working on ways to improve this.
- In addition to these questions, the RD also asked where do we have exhibits in our area? I believe this is meant to be things like where do we have pamphlets out other than in H&I facilities

- Please encourage your groups to read the CAR, have the discussions, take the votes, and bring them back to me to pass along to our Regional Delegates.
- The workshop put on by LARNA went pretty well, and we had what I would consider better than expected participation from our area, with a lot of good questions and discussion. Thank you to everyone who participated.
- In speaking with ASR of New Orleans Area, Don B, we think it would be beneficial to combine efforts and host a watch party, likely mid to late February. I am requesting \$100 towards this effort for half of the cost of the facility and refreshments. I don't currently have a flyer or date, but would like to request that the Area sign off on the event so that I could be reimbursed, provided I return with the proper receipts.
- Upcoming Events include (Flyers out on table)
 - February 7, 6-9pm in BR there is a Valentines Function at St. Paul's Lutheran
 - February 21 – Mardi Gras Ball – Abita Town Hall 6-10pm, \$20 Suggested
 - LRCNA May 22-24 (promising great attendance with 90% of rooms already booked – planning to get more) The flyer includes QR Code for the Hotel, Registration, and Volunteers (they are very much in the need for volunteers!)
- Discussion about the Insurance –
 - Insurance was brought up and will be planned to be paid for prior to the next Regional meeting. Will likely be around \$4,900
 - Concerns were voiced regarding Unity Area's concerns about the insurance, what it covers and whether it is needed
 - It is for liability – it covers the homegroups if anyone had an issue and tried to sue
 - Homegroups are not legal entities, neither are areas, but LARNA is
 - It covers all homegroups on the meeting list
 - It may be difficult to actually successfully sue though
 - Having this insurance also provides a writer so that events are covered as well, they must be contacted though.
 - It also covers the Regional meetings
 - Whether or not it is needed has been up for debate for quite some time
 - The number for "Equal Stephen" was provided as a person who is noted to be able to explain the insurance in greater detail – has not been contacted yet, though
- LARSCNA expressed that with the financial difficulties in attempting to follow the guidelines as written and send money to World and SZF out of the total funds, and

the inability to effectively get the matter resolved via a vote that was brought back to areas, a motion was made to settle at regional level as it was directly impacting the region's functionality and was being held in limbo for an unreasonably excessive amount of time. The motion passed and a secondary motion to change the wording to include that only unencumbered funds would be considered for donation was made and passed. This allowed region to lift the suspension on donations and a donation was made for 10% of the unencumbered funds to go to world, and 3% to SZF.

- Next LARSCNA meeting is to be held April 11-12, 2026 in New Orleans Area. I would like to note that this was supposed to have been the Greater Baton Rouge area, but New Orleans will be doing it instead due to lack of participation from GBR. I'm not positive, but I think this may bump us up in the rotation for hosting region. I will double check this prior to next area.
- Please note that I may not have covered everything. My report was rushed for personal reasons, but I tried to cover the things I considered most likely to be most relevant to the area.

Thank you for allowing me to serve in this role.
