LRSCNA Last meeting July 11-12, hosted by Bayou Recovery Area.

The minutes have been received and sent to the PR chair to post to the website, which I believe to have been done. I am afraid that I must apologize for the tardiness of the minutes- they were apparently sent August 1, but went to spam and I did not see them until yesterday. I have added the sender to my contacts in hopes that this won't happen again.

I do highly recommend reviewing the minutes, in particular the RD report which starts around page 6, as there are many significant points of interest.

I won't go over everything, but just as a (very) brief mention on what this area voted on previously:

Motion #1, Approval of revised IP #21 – Passed

Motion #2, Adoption of the Strategic Plan, the motion was passed based on greater than 80% being in favor in the pre-conference straw poll.

Motion #3: WCNA by WB, Every 5 years, Revenue neutral location choice - Passed – all amendments failed

Motion #4: Book length literature for tablets project plan – Passed

Motion #5: AI interpretation for WSC and CP meetings, replacing human interpretation – Failed at the straw poll level, with the in favor being only 18%, a vote was called on whether to hear the amendments, and failed with less than 2/3 in favor, so the amendments were never even heard.

Additionally, World has shared an update about proposed Gender-inclusive wording changes to IP#1 and asked members to review and give input by the end of October. Key points of interest for our groups:

A draft of IP #1 with the proposed changes is now posted at na.org/genderproject

Only 4 specific wording changes are proposed, the steps and traditions are not being

Feedback is open through October and Final Decisions will go through the 2029 CAR
